### International Objects:

1. To form a nucleus of the Universal Brotherhood of humanity without distinction of race, creed, sex, caste or colour.
2. To encourage the study of comparative religion, philosophy and science.
3. To investigate unexplained laws of nature and the powers latent in man.

### English Section Objects:

*The objects of the English Society are for the public benefit to promote moral and spiritual welfare, for the advancement of education, through the promotion and study of Theosophy, and the dissemination of the results of such study to the public.*

### ANNUAL SUBSCRIPTION:

The Associate Fee of £10 is payable from 1<sup>st</sup> October each year. For Associates joining after 30<sup>th</sup> June, the Annual Fee will not need to be renewed until 1<sup>st</sup> October the following year, so may remain current for up to 15 months. Financial hardship shall not be a barrier to joining as an Associate.

The maximum period allowed for Associates living in the UK is two years after which Associates must decide whether to join as a Member. Associate status is not available for lapsed Members.

The maximum period allowed for Associates living overseas is indefinite. This is because those living abroad may only become a Member of the Society in their own country or when there is no National Section as a 'member at large' attached directly to TS International Headquarters.
